Payments can be made by mail, in person or in the drop box outside of the Victor Township Hall. You are encouraged to pay your property taxes by mail; however, the **postmark dates DO NOT serve as payment dates.** Payments must be in the office by 5:00 pm on the due date or penalty and interest will be charged. If you decide to pay in person the office is open

Monday through Friday 1:00 pm to 4:30 pm. Make checks payable to Victor Township Treasurer. If you are paying with cash please have exact change.

**We do not keep cash on hand in the office.**

### Treasurer's Office Hours

The Treasurer will be in the office to accept payments on most Tuesdays from 5:30 pm to 7:30 pm or by appointment. The Treasurer's office will be open December 29<sup>th</sup> 2017 from 9:00 am to 5:00 pm to accept tax payments.

**The Treasurer will also be in the office from 9:00 am to 5:00 pm on February 14<sup>th</sup> and February 28<sup>th</sup> 2018, the last day Victor Township can accept 2017 taxes.**
