RESOLUTION NO. 09062016, RESOLUTION TO RESCIND ORDINANCE NO. 19.3, VICTOR TOWNSHIP FIRE, AMBULANCE
AND INHALATOR SERVICE CHARGES ORDINANCE**

At a regular meeting of the Township Board of the Township of Victor (the "Township"), Clinton County, Michigan, held at the Township Hall in the Township on September 6, 2016 at 7:00 p.m., Eastern Standard Time.

The following resolution was offered by Wall and supported by Willoughby.

WHEREAS, the Township regulates the Establishment of Fees, Time for Payment of Charge and Collection of Charges, Exemptions, Non-Exclusive Remedy, Multiple Property Protection, Prohibited Fires, Burning Permits Fees, Burning Without A Permit Or In Violation Of Permit, Penalties, Appeal Of Fire Run Charges, Severability and Effective Date under Ordinance No. 19.3, Victor Township Fire, Ambulance and Inhalator Service Charges Ordinance (commonly referred to as Collection of Fees for Fire Protection); and

WHEREAS, the Township wishes to rescind Ordinance No. 19.3

WHEREAS, on or about January 2, 2008 the Township Board adopted it Ordinance No. 19.3, known as "Fire, Ambulance and Inhalator Service Charges Ordinance" desires to rescind by adopting Ordinance No. 30, Victor Township Ordinance To Rescind Ordinance No. 19.3, (the "Ordinance") to repeal Ordinance No. 19.3; and

WHEREAS, the Township Board has determined that it is in the best interest of the public health, safety and welfare to rescind the Victor Township Fire, Ambulance and Inhalator Service Charges Ordinance.

NOW, THEREFORE, the Township Board of the Township of Victor resolves as follows:

1. Ordinance No. 30, Ordinance To Rescind Victor Township Fire, Ambulance and Inhalator Service Charges Ordinance, attached as Exhibit A, is hereby rescinded.
2. The Ordinance shall be filed with the Township Clerk.
3. The Township Clerk shall either publish the Ordinance in a newspaper of general circulation in the Township or post the Ordinance in the Township Clerk's office and on the Township's website and publish a Notice of Posting of Adopted Ordinance in a newspaper of general circulation in the Township within 30 days of adoption.
4. Any and all resolutions that are in conflict with this Resolution are hereby repealed upon the effective date of the Ordinance, but only to the extent necessary to give this Resolution full force and effect.

THE RESOLUTION WAS DECLARED ADOPTED.
