Call to Order and Pledge

The regular monthly business meeting of the Victor Township Board was held at the Township Hall, 6843 Alward Road, Laingsburg, MI 48848. Supervisor Warren Malkin called the meeting to order at 7:00 p.m. The pledge to the flag was given.

Agenda - Malkin moved, second by McDonald and motion carried to approve agenda with addition of 2009 meeting schedule under new business.

Minutes and Treasurer Report - Minutes of the November 5, 2008 regular meeting were approved as printed. The treasurer's report was accepted subject to audit and placed on file.

Approval of Bills - Wilsey moved, second by McDonald and motion carried to make the following budget adjustment: increase parks and recreation (101-751-727-00) by \$530.22 and decrease capital outlay (101-901-970-00) by \$530.22. McDonald moved, second by Malkin and motion carried to pay bills in the amount of \$34,257.12, check #s 10434-10458.

Reports

Planning: Stephens to take lead/initiative in setting up a joint educational session/discussion with Twp board and planning commission on wetland ordinance issue. Discussed draft letter to Salyer and County. Commission will ask county for breakdown of fees paid. Chadwick will revise letter and send to county. Will not send a letter to Salyer at this time. Malkin, with concurrence by the board, requested that the letter be sent to township prior to being sent to the County. Ginther to follow-up with Chadwick. Commission discussed wind seminar at MSU - Hazle may attend. Discussed Tenlen complaint – will request copy of complaint from County. Next meeting is December 17, 2008, 7 p.m., Victor Township Hall.

Clinton County Economic Alliance: SBTC business seminar was attended by about 40+ people. CCEA is hosting a presentation by George Erickcek, Sr. Regional Analyst, UPJohn Institute, "State of Michigan Economy and the Impact on Clinton County" at its board meeting December 9, 2008, 7:30 a.m., CC RESA, 1013 S. US 27, St. Johns. Members and public invited. CCEA met with Dewitt and St. Johns DDAs, Sleepy Hollow State Park to discuss public transit from the park to downtown centers.

Clinton County Officials - County Commissioner Terry Link reported on openings on 4 county bodies – ag preservation, clinton area transit board, historical commission, greenspace commission. Board passed county park rules. DNR money has been appropriated and county support has been committed for Motz County Park. Plans are underway for design for Motz County Park. RESA students will participate in construction. Activity should begin in the spring. Greenspace meeting on Friday.

International expansion of airport requires a plan to handle waste. Installation of an incinerator for waste from international flights proposed. Proposal is under review and site committee is being appointed. Commercial rehabilitation district on US 27 in Dewitt proposed. Green Government Initiative (GGI) continues. Road Commission has installed idling equipment on trucks. Facilities energy efficiency improvements are also under review. Most parts of county government are participating in GGI.

Deputy Alward reported on Blood Cemetery vandalism. Prosecutions of juveniles involved in vandalism of Blood Cemetery is progressing. Reward will be determined once prosecution is complete. Reports of identity theft is on the rise. Deputy Alward advised that personal information should never be revealed on the telephone or on-line.
