Call to Order and Pledge -

The regular monthly business meeting of the Victor Township Board was held at the Township Hall, 6843 Alward Road, Laingsburg, MI 48848. Supervisor Warren Malkin called the meeting to order at 7:00 p.m. The pledge to the flag was given.

Roll Call of Members -

Members present: Warren Malkin, Michelle Wilsey, Donald McDonald, Duane Ginther, and Dan Morris. Members absent: None. Other governmental representatives in attendance: None. Six (6) citizens present.

Agenda – Morris suggested having a notary in the township. Morris moved, second by Wilsey and motion carried to add township notary to the agenda under new business. Ginther moved, second by Morris and motion carried to adopt the agenda as amended.

Minutes and Treasurer Report – Minutes of July 6, 2010 regular board meeting accepted as printed.

Treasurer's report was accepted and placed on file subject to audit.

Approval of Bills –

Planning: July meeting was held. Planning commission recommended approval of parks and recreation plan with suggestions of improving playground as first priority and possibly adding grills by pavilions in the future as funding permits. Soccer nets are damaged by weed trimming. Planning commission would like mower to find alternate method of controlling weeds such as Round-up around the base of the goals to avoid tearing. Planning commission also recommended removal of trailer boxes near soccer fields. They also suggested the board consider selling Round Lake alleys to raise funds for other uses. The Twp Board noted that the alleys were public lands not transferrable to private owners. If the township relinquished the alleys they would go to the MI-DNR. Motion by McDonald, second by Wilsey to adopt a Resolution approving the following 2010 Millage Tax Rate Request for Victor Township be submitted to the Clinton County Board of Commissioners for approval: operating 1.0000, extra voted roads 1.5000, and extra voted fire authority operations 1.5. Upon a roll call vote the following voted yes: Malkin, McDonald, Ginther Morris, Wilsey. The following voted no: None. The following were absent: None. The supervisor declared the motion carried and the resolution adopted.

Wilsey moved, second by Malkin and motion carried to adopt the following amendment to the FY2010-11 budget: Increase budget 101-336-727-02 by \$9,119.00. Retire accounts 101-265-921-01, 101-265-921-02. Allocate Mike & Son parking lot resurfacing expense in amount of \$1,950 to account 101-336-727-02.
