Moved by Malkin seconded by Wall, to accept the agenda with the addition of Township Lawn Maintenance Contract. All in favor, motion carried.

Moved by Malkin, seconded by McDonald to accept the minutes of July 2, 2013 as written and place on file. All in favor, motion carried.

The Supervisor accepted the Treasurer's Report to be placed on file.

Moved by McDonald, seconded by Wall, to pay the payroll in the amount of \$7,133.00 with check numbers 11410-11418. All in favor, motion carried.

Moved by McDonald, seconded by Malkin to pay the accounts payable in the amount of \$7,418.79 with check numbers 25189-25206 voiding 25186-25187. All in favor, motion carried.

Moved by Preston, supported by Malkin to recommend approval of the request from Kraus to enter into a PA -116 with the State of Michigan for Parcel ID# 140-005-300-006-00. All in favor, motion carried.

Moved by Wall, supported by McDonald to table the protest of Fire Fees from Woodend & Li until more information can be gathered. All in favor, motion carried.

Moved by Malkin, supported by Wall to recommend approval to the Clinton County Planning Commission of the request for Medical Hardship Housing, PC-24-13-SL, with a three month time period for removal of the temporary modular/mobile home. All in favor, motion carried. Abstained – Preston.

Moved by Preston, supported by Wall to expand First Choice's contract to include the Hall/Grounds Maintenance Contract, the terms of the contract held previously by Natures Way will be extended through March 31, 2015. All in favor, Motion Carried.
