VICTOR TOWNSHIP BOARD June 6, 2017 APPROVED REGULAR MEETING MINUTES

Planning Commission Representatives Sayles with input from Kim Dutcher reported information regarding the township 10 year Comprehensive Plan. The Master Plan needs to be brought up to date. Public input and review will be required. Doug Riley will be present to discuss hiring a consultant at meeting at 6:30 on June 22, 2017.

LSW Representative Wall reported that he will draft letter from Victor Twp. requested from Clinton Co. 911. Shawn Smith and Wall are making progress on Station 3 improvement plan re: exhaust system, presented costs and requested authorization to purchase and install Active 911 equipment making Station 3 consistent with other LSW stations. Moved

by Sayles, supported by Smith to approve proposal. All in favor. Motion carried. Activity report for May includes 10 calls total: 7 rescue calls, 2 structure fires and 1 personal injury accident.

Wall also mentioned he and Shawn are working on replacing Stilson Cemetery pump and investigating if the well has run dry.

Adam Stacey County Commissioner discussed details about how the county uses township master plans.

- Planning Commission Meeting Stipend Proposal-Moved by Wall, Supported by Willoughby, to adopt policy to allow stipend for Planning Commission meetings and to set rate at the July meeting. The amounts other townships allow will be investigated by staff and recommended. All in favor. Motion carried.
