We expect to get a response back from DNR in a couple months as to possible additions/improvements we can make to our grant application. Ms. Fickes will keep the board updated.			

Township Parking Lot	At the site review on June 20 <sup>th</sup> , Ms. Fickes will ask Erin Campbell for input on possible ways to increase parking on the township property given our grant application and future improvements planned.	
5 year Road Review	Mr. Dutcher updated the board on the status of Jason Road. It has been resurfaced but the gravel for the shoulders and the stripping has not been done yet. There are some alignment issues around one curve in particular. The new pavement is offset a couple feet from the existing roadbed. Mr. Dutcher and Mr. Walls will work with the county to find a solution.  There were not enough funds to work on the northern section of Hollister that had been discussed at previous meetings. The work on Jason Road used all the funds allotted for road work in 2018.  The planning commission discussed touring all the roads eligible for township funds this summer. Additionally, we would like to do a tour of the township cemeteries. We are tentatively considering Hollister Road for resurfacing for 2019 (as on the 5 year plan).
