6.	The CONTRACTOR shall provide proof of liability insurance coverage to remain in effect for the duration of this contract, in an amount determined to be commensurate with the services provided. The CONTRACTOR will be required to notify Victor Township in writing of any damage to the township facilities and property caused by the CONTRACTOR.
7.	The CONTRACTOR shall perform all the services in compliance with all applicable Federal, State, and local laws, ordinances, rules and regulations.
8.	Modifications, amendments or waivers may be made only by written mutual consent of both parties to this Contract. The CONTRACTOR is not permitted to transfer any part of

this contract to another party without written approval from Victor Township.

LOCATION OF TREES TO BE TRIMMED OR REMOVED

Blood Cemetery

By Hart stones near Bixby – Remove large limb going south and dead branches

Between Kennedy and Montage stones – trim dead branches on 2 trees

At Kennedy stone – cut/remove multiple young trees, spray stumps to limit regrowth

At east fence line – trim dead limbs hanging over cemetery

East Drive near back – Trim dead limbs hanging over fence and over cemetery

Center Back – Trim big tree with dead branches hanging over cemetery

By Swarthart stone – Trim lower branches of young tree (all but 2 limbs in center)

By Dietrich stone – Trim 2 shrubs from ground to 10 feet up and young growth

By Parker stone – Trim dead branches of Pine tree

Reed Cemetery

By school and parking lot (across from Reed) – Trim several dead branches off Sugar Maple

East Drive – near entrance/road – remove dead tree and stump

East Drive – near Remus stone – Remove tree (east most tree of 3 tree cluster)

East Drive – near Strouse stone – Trim big limbs of tree (caution: bees nest)

East Drive – near Brown stone – Trim tree near overhead lines

East Drive – near DeVault stone at the fence near entrance – Trim several branches of tree

West Drive – near Foster stone – Trim broken/dead stubs of tree

West Drive – near Morrison stone – Remove short Cherry tree and stray stump to limit regrowth

West Drive – near Holden stone by fence – Trim 2 limbs of tree

Back Drive – near Sindall stone – Trim branch over drive

Back Drive – near Mikko stone – Trim large branch over drive

Center Drive – by Parker stone – Trim 3 spruce branches up 20 feet from the ground

Stilson Cemetery

Front of cemetery near Ramsey stone – Trim center limb of tree

Between east and center drives by fence, near Skarrett stone – trim 2 large dead limbs

Front of cemetery near See stone – Trim three limbs of tree

Back Row – Remove dead Pine tree and stump

Back Row near Freeman stone – Trim 2 trees with dead branches

Near Eiserman stone – Remove large dead limb (going east) of large white oak

Between Crane and Barnes stones – trim off small dead limb

North center, near Underhill – Remove 2 young trees (hickory and elm) – spray to limit regrowth

By Beckwith stone – trim off low branch

Front by fence – remove center dead limb
