- **Zoning PC-28-23 SLU** Mr. Sell motioned to approve application, contingent on a definition for "temporary" and timeline for re-assessments of need in order to prevent a permanent structure. 2<sup>nd</sup> by Ms. Townsend. Roll call vote: Ayes: Ashley, Mitchell, Townsend, Sell, Marek. Nays: Ginther. Absent: Malken. Motion carried.
- Mercy Ambulance Mr. Ginther shared that he had spoken with an owner of Mercy who had indicated they had low staff levels. Mr. Ginther shared concerns the LSW may be facing same challenges.
