- Internet workgroup update Mr. Sell gave updates on developments including latest GIS mapping additions, Verizon acquisition of Frontier communications, and the rural readiness grant. Mr. Sell noticed the link on Township website to check addresses for BEAD was broken, he coordinated a fix with Mr. Marek.

- DNR Grant preparedness- Mr. Mitchell shared that he and Board member Fickes had met with Riley Millard on the Grants being moved forward. While the grant application is very strong and well prepared it has come to light that the Township will need to augment the grant app with an "archaeological dig" The hopes is to move forward with the grant application whilst the dig is scheduled, Mr. Millard is currently looking into if that will be permissible. In the case that we must remove the application all the "legwork" has been done; we can easily file again next year once dig is complete. Currently cost and timeline for a dig is unknown. Mr. Mitchell will have more updates at next meeting.
