Proposed Planning Commission Minutes from June 3, 2025 Meeting

The regular meeting of Victor Township was called to order by Tammy Ashley at 7:04 pm.

Unfinished Business:

- Internet workgroup update– Ms. Ashley had no new updates.
- Road network/Cemeteries – Ms. Ashley reported the cemetery group met yesterday and sorted out the headstone pieces and only found a few that names are there. Members are researching a possibility of seeking a person to help create a design.
- 2025 plan goals – Mr. Sell will update previous bids for kitchen equipment to ensure they are accurate with respect to recent inflation. Tabled to next meeting
- Update on soccer clubs – Mr. Mitchel had no update and no report back from supervisor.
- Grant Award Update – Ms. Ashley stated that C2AE did not have a report of their findings. It was found that the presumed survey stakes that were beyond the township property lines were “reference stakes” for survey process and that indeed the survey stakes of Mr. Malkin were correct.

New Business:

- Historical group will the group will meet June 16, 2024; 7 PM to continue work on the headstone project.
 - Smaller sign like on church and school would like to be requested for the garden.
- Group toured the hall in order to look at lay out for the update of the township hall and kitchen.
 - Recommendations consider using the polished concrete for all of the floors after the hall floor repairs have been done.
 - Remove kitchen cupboards for open stainless-steel shelving and countertops for durability

- Remove the door on the hallway to the kitchen to allow for larger refrigerator
 - Mr. Sell can provide commercial equipment suggestions and layout
- Discussion that group will begin to look at the 5 year Victor Master Plan and consider planning to survey the township in beginning preparation for the next 5 year plan update when all members are present.
