Approved Board Minutes of August 11, 2026

The regular board meeting of Victor Township was called to order by Supervisor Wiswasser at 7:01 p.m. The Pledge of Allegiance was recited, followed by a roll call of Board members in attendance. Present: Wiswasser, Prange, Pesch, Sayles, Willoughby. 3 citizens were present.

Public Comment:

Approval of Agenda: Motion by Prange, seconded by Willoughby, to approve August 11, 2026, agenda with additions submitted by Supervisor. Motion carried unanimously.

Approval of Minutes: Motion by Willoughby, seconded by Pesch, to approve July 14, 2026, regular board meeting minutes. Motion carried unanimously.
Motion by Prange, supported by Sayles, to approve August 5, 2026, special meeting minutes. Motion carried unanimously.

Treasurer's Report: Motion by Prange, seconded by Willoughby, to accept the August 2026 Treasurer's report. Motion carried unanimously.

Approval of Bills and Payroll: Motion by Wiswasser, seconded by Willoughby, to disburse July 2026 bills. (Paid August 11, 2026) excluding check **12918** to be voided. Roll call: Members voting yes: Prange, Pesch, Wiswasser, Willoughby, Sayles. Motion carried. **Checks # 12919-12931**, in the amount of **\$138,055.30** (This includes payment to hall renovation project.)

Motion by Willoughby, seconded by Sayles, to disburse July 2026 payroll and payroll related expenses. (Paid August 11, 2026). Roll call: Members voting yes: Pesch, Sayles, Willoughby, Wiswasser, Prange. Motion carried. **Checks # 13391-13417** in the amount of **\$21,489.89**

Planning Commission Report: The Planning Commission is working on goals for the Master Plan.

Cemetery Director: The mausoleum has been taken down, and the area will be assigned to burial spaces for sale once the cement foundation is removed.

Maintenance and Facilities: Motion by Pesch, seconded by Wiswasser, to purchase 3 toilet paper holders for the park restrooms at a cost of \$115.00. Roll call: Members voting yes: Wiswasser, Willoughby, Pesch, Sayles, Prange. Motion carried.

Round Lake Special Assessment : The process is underway to create a special district to collect monies for weed control at Round Lake. We are waiting on the plan from the Round Lake Property Owners Association to proceed. Motion by Prange, seconded by Sayles to hold 2 public hearings regarding the special assessment on September 8, 2026, and September 23, 2026. Notices and letters to those affected will follow. Motion carried unanimously.

New Business:

Hall Renovation Project: Motion by Willoughby, seconded by Pesch to update all door locks and hardware using Secure Lock & Door. Roll call: Members voting yes: Sayles, Wiswasser, Pesch, Willoughby, Prange. Motion carried. Motion by Prange, seconded by Wiswasser to approve purchase of hall kitchen appliances

MTA Planning Workshop: Motion by Willoughby, seconded by Pesch, to send 2 planning board members to MTA workshop for Planning Boards. Members voting yes: Pesch, Willoughby, Wiswasser, Prange, Sayles. Motion carried.

Generator Battery: Motion by Sayles, seconded by Willoughby, to approve purchasing a new battery for the Township generator in the amount of \$188.00 from Michigan Critical Power. Roll call: Members voting yes: Prange, Pesch, Willoughby, Sayles, Wiswasser. Motion carried.

L4029: Motion by Sayles and seconded by Pesch to approve the 2026 L-4029 tax statement of monies. Roll call: Members voting yes: Pesch, Willoughby, Wiswasser, Sayles, Prange. Motion carried.

Motion by Sayles, seconded by Pesch to adjourn at: 8:45 p.m. Motion carried unanimously.
